Data Controller

The Controller of your personal data is Dom Development Kredyty Sp. o.o o.o., Pl. Piłsudskiego 3, 00-078 Warszawa (the "Controller"). The Controller has appointed a Data Protection Officer, whom you may contact with respect to any matters relating to the protection of your personal data, by email at: <u>iodo@domd.pl</u> or by post at the address of the Controller's registered office, with the note "PDPO".

Definitions

- 1. Client a sole trader, legal person or any other unincorporated entity that requests actions from the Controller,
- 2. persons acting on behalf of the Client any individual who contacts employees and/or representatives or attorneys-infact of the Controller in order to present a request based on which the Controller will take actions; these may include, but are not limited to, the employees of the Client or other persons appointed by the Client or acting on its behalf (personnel and representatives – members of the Management Board, attorneys-in-fact).

Source and Scope of Data Collected

The Controller collects data directly from the Client or persons acting on behalf of the Client. The Controller collects identification data, including business-related and other information, necessary to provide financial brokerage services or to fulfil request made by the Client or persons acting on its behalf. The Controller may also obtain data from the entity for whom the Controller provides credit brokerage services in order to take actions prior to the conclusion of the contract or in connection with its execution. The Controller processes only the data necessary for the above-mentioned purposes.

Purpose and Legal Basis of Data Processing

The Controller processes personal data of the Client and a person acting on behalf of the Client for the following purposes:

- a) taking actions, at the Client's request, prior to the conclusion of a contract, such as preparing and presenting offers from entities, for whom the Controller provides financial brokerage services, as well as carrying out activities related to the provision of financial brokerage services, in particular assisting the Client in obtaining finance; the contract may be concluded orally during a meeting with the Controller's representative (Article 6(1)(b) of the GDPR),
- b) the establishment, exercise or defence of claims (if any) (Article 6(1)(f) of the GDPR),
- c) surveying customer satisfaction and the identification of service and product quality, which constitutes a legitimate interest of the Controller (Article 6(1)(f) of the GDPR),
- d) settlement and tax purposes it is a legal obligation resulting from tax law, the Accounting Act, and other tax laws, including for the purpose of proper settlement of financial brokerage services (Article 6(1)(c) of the GDPR),
- e) compiling statistics, which constitutes a legitimate interest of the Controller (Article 6(1)(f) of the GDPR),
- f) carrying out marketing activities, which constitutes a legitimate interest of the Controller (Article 6(1)(f) of the GDPR).

Period of Data Processing

Your personal data will be processed:

- a) with regard to actions taken prior to the conclusion of a contract for 24 months,
- b) with regard to the establishment, exercise or defence of claims for 24 months,
- c) with regard to surveying customer satisfaction for 24 months or until you object to the processing,
- d) with regard to tax settlements and accounting for 5 years from the end of the tax year,
- e) with regard to compiling statistics until you object to the processing,
- f) with regard to marketing activities until you object to the processing.

Data Recipients

Your personal data may be shared primarily with banks with whom the Controller cooperates, as well as other entities that cooperate with banks and the Controller in the process of financial brokerage services provision. Your personal data may also be shared with providers of IT, accounting, archiving, debt collection systems and services or other systems and services necessary for the proper satisfaction of the request of the Client or a person acting on behalf of the Client on the basis of data processing agreements concluded by the Controller, as well as service providers, who are separate data controllers (such as telecommunication companies, postal companies, banks, and law firms) and have a legal or contractual duty of confidentiality, providing specific services to the Controller.

Data Subject Rights

You have the right to request: access to the data and receive a copy, rectification or erasure of the data, the restriction of your data processing, and, for a Business Partner who is a sole trader, additionally the transfer of the data; and filing of a complaint with the supervisory authority competent for data protection (President of the Personal Data Protection Office). You also have the right to object to the processing of your personal data on the basis of the Controller's legitimate interest, for reasons associated with your particular situation.

Voluntary Data Provision

The data provided by you is necessary for the provision of financial brokerage services by us. Your failure to do so will prevent the provision of such services. You provide your personal data voluntarily. Failure to provide this data will render it impossible for the Controller to process your personal data in order to provide services, offer products, or conduct direct marketing of products and services.
